## **1 BACKGROUND**

The Initiative for Responsible Carnauba (IRC) is supporting carnauba processing companies in Brazil to improve conditions in the carnauba wax sourcing areas, as well as finding new approaches to the many social and environmental challenges in the associated sector.

Ultimately, the aim is to foster a responsible carnauba wax supply chain that respects people and helps preserve biodiversity in carnauba wax producing areas in the unique semi-arid (Caatinga) biome of northeast Brazil.

Environmental and social challenges have come to light in some of the carnauba wax extraction areas in northeast Brazil, including high rates of deforestation (of the native Carnauba palm trees), degradation of local biodiversity, persistent drought, rapid expansion of invasive species, as well as poor working conditions and low pay. These problems are often systemic, with a wide range of factors involved that contribute to the challenges.

The **Initiative for Responsible Carnauba** includes a variety of stakeholders from local processing companies of carnauba, buying companies, international and sustainability standards organisations. Moreover, stakeholders in the initiative can rely on a network of local experts when specific expertise are needed to tackle social, economic and environmental issues.

To date, the IRC has developed an action plan focusing on good harvesting practices, traceability and transparency of carnauba wax origins, and shared learning and training. The IRC will test new approaches first, and then implement particularly promising ones. It plans to involve as many supply chain actors as possible, to increase the participation of suppliers and buyers, and to include social interest groups as well.

# **2 THE RESULTS**

The IRC is now starting to monitor the results of its promoted actions. Some KPIs (Key Performance Indicators) are defined in a participatory way by the stakeholders involved.

They concern the socio-economic and biodiversity aspects tackled by the initiative (Table 1). Stakeholders in the IRC are asked to provide information, which is verified and summarised into reports. Reports are drafted every six months to summarise progress. Impact studies will be conducted to assess the impact of the IRC's actions. Those are to ascertain what are the effects of those actions on the socio-economic and biodiversity conditions in the Carnauba collection areas.

To date (February 2020) there are 20 members in the IRC. Three of them are Brazilian processing companies, the rest include buyers of Carnauba, one standards organisation and an international organisation. Information reported in the following sections covers 14 members<sup>2</sup> of the IRC that have reported, since they were the companies and organizations that were part of the IRC at the time of the reporting date of 30 June 2019.

<sup>1</sup> The group decided to only count as Responsible Produced Carnauba (RPC) the ingredient that is UEBT certified. The group is also opened to consider other certification schemes to be potentially recognised as RPC for the IRC in the correct moment. The group has already defined that organic certification cannot be counted as this certification scheme does not consider social aspects.

<sup>2</sup>Other current IRC members (ref. November 2019) have not responded to this enquire because they were not part of the IRC in 30 June 2019 (cut-off date to participate in the report).

## **3 PROGRESS AGAINST KPIs**

Information in Table 2 below is for the reporting period January through June 2019 and compared against the prior reporting period for calendar year 2018.

Information for indicators 4, 5 and 6 were collected but are not reported to respect confidentiality<sup>3</sup>.





Figure 2 Number of IRC members

<sup>3</sup> The protocol signed by the members of the Initiative state that information is shared in aggregated form, and in a way that cannot be reconnected to the organisation providing it. This implies that at least three carnauba processing companies from Brazil will need to be involved before information can be reported.

#### Some highlights from the results presented above

- The number of IRC members increased 64% during the first semester of 2019.
- The total amount invested in the activities of the IRC was higher in the first semester of 2019 than it was during the entire 2018 calendar year.
- Most of the private investments are from the local processing companies in Brazil.

- Examples of investments include:
- Time spent in meetings and trips for IRC
- Development of communication materials and marketing
- Development of guidance materials
- Training of workers in field, distribution of personal protective equipment
- Implementation of UEBT Biodiversity Action Plans, including actions to combat invasive species, seed banks, seedling nurseries of native species, etc.
- Implementation of a research and training center in Brazil
- Baseline study on biodiversity
- Assessments of suppliers and support on implementation of workplans.



## **4 NEXT STEPS**

The IRC is now in a development and approval stage for its strategic milestone actions for the coming years. Once this is agreed, the information will be made publicly available.
